Terms of Application (Applicants must meet and agree to all conditions outlined in this application):

- **DUE TO ISSUES IN THE PAST THERE WILL BE ABSOLUTELY NO CARRYING IN OF VENDOR FEES. ONLY THOSE VENDORS WHO HAVE PAID THEIR VENDOR FEES IN FULL BY THE DEADLINE WILL BE ALLOWED.**
- **Vendors will receive confirmation along with a map designating location of booth space if their application has been accepted. Vendor booth space will be assigned by the Stewart Father's Day Powwow Committee on a FIRST COME FIRST SERVED BASIS.**
- **This form must be received by June 11, 2010. Full payment is due with return of this form. NO EXCEPTIONS.** There are no refunds after June 11, 2010.
- **Booth size is 10ft.X10ft. If your booth size is larger than the approved booth size you will be required to pay for the additional space. This too will need to be paid prior to the June 11th deadline or you will not be allowed to participate.**
- Vendors are not permitted to relocate their booths or sell outside of their assigned area. Subletting is prohibited. There will be no mobile sales (carts, trays, etc.).
- The Stewart Father's Day Powwow will accept original applications from Native artists and only those who demonstrate a positive image for and about Native people. The Stewart Father's Day Powwow Committee prides itself upon attempting to maintain the highest quality of vendors and reserves the right to remove all unauthorized merchandise and materials deemed inappropriate.
- Any vendors who park in unauthorized parking areas will be towed.
- **THREATENING BEHAVIOR OR LANGUAGE WILL NOT BE TOLERATED AND VENDORS WHO EXHIBIT THIS BEHAVIOR WILL BE ESCORTED OFF PROPERTY.**
- NO liquor, beer, or wine sales are permitted.
- Set up and take down is the sole responsibility of the vendor.
- This is an outdoor event. Uneven terrain, inclement weather and wind gusts will occur. Prepare your booth accordingly.

- **The Stewart Father's Day Powwow Committee is not liable for loss or damage to the property of exhibitors. Valuables should be put away for safe keeping each night.**
- Reporting Nevada sales tax is the sole responsibility of the vendor.
- Assigned booth space and surrounding area must be left clean; don't leave anything behind. **Vendors who do not comply will not be invited back.**
- Indian Taco Vendors are limited to Four (4). The Committee will accept the first 4 completed and paid Indian Taco Vendors. Those who would like to be a food vendor, selling other than Indian Tacos and Fry Bread, may still apply.
- All food items must be properly prepared or preserved according to Carson City Health Department rules. All food vendors must obtain a **Health Permit from the Carson City Health Department** at 900 E. Long Street, Carson City, NV (775-887-2190). All food vendors must have a **2A-20BC rated Fire Extinguisher** on site. All licenses and permits must be with you at your location during the event.
- All vendors **MUST** be completely self-contained. Power, lights, tables, chairs, shade tents, water and garbage services are NOT included. **ONLY** space is provided. Generators are allowable.
- **ONLY** those items stated and approved in this application shall be sold. **Snaps or bombs of any sort are strictly prohibited.** Prices must be posted in a legible manner.
- Informational booths are for information only (no sales allowed of any kind).
- All booths must be properly manned at all times.

By submitting this application I agree to abide by all Rules and Policies set forth by the Stewart Father's Day Powwow Committee. I understand that the use of alcohol and or drugs is not allowed and will result in removal from Powwow with NO REFUND. My signature acknowledges the fact that I have read and understand the Rules, Regulations and Policies of the Stewart Father's Day Powwow Committee and will abide by these and all subsequent requirements. The Stewart Father's Day Powwow Committee reserves the right to instruct the vendor to remove all unauthorized merchandise and materials deemed inappropriate from display and for sale, and to remove vendor from the event if necessary. There will be no exceptions to the stipulations outlined in this application.
